WEBSITE SECURTY

The Summit Club website uses Secure Socket Layer (SSL) for authentication and private communications. We do this to build users' trust and confidence in the internet and our website. The encryption is SHA-2, 2048 bit level. GoDaddy, our hosting service, is the SSL certificate authority CA. Malware and blacklist scans are run daily to protect against any hacks or malware intrusions. The servers are protected by advanced firewall settings to prevent hacking and brute force attacks.

INFORMATION PRIVACY

This Policy will inform you of the following:

- 1. What personally identifiable information is collected from you through our website
- 2. Why we collect personally identifiable information
- 3. How we use the collected information and with whom it may be shared
- 4. What choices are available to you regarding the use of your data

Information We Collect

It is always up to you whether to disclose personally identifiable information to us. For members, we collect information about your dues, donations, and events payments (i.e. meeting meals, outings, etc.)

For non-members, information is collected through our donation page and through our commerce system which is used to support the sales of event ticket and sponsorships for our Western Saloon & Casino Night (WS&CN) fundraiser.

The personal information that we collect for the WS&CN fundraiser includes various items such as name, address, phone number and email address. We also collect the order detail information for any purchases. The personal information collected is used to identify you to make sure you get the correct tickets when you attend WS&CN and to contact you in case there is an issue or question. We also may use this information for marketing purposes or for future Western Saloon & Casino Night events.

You have the option to create an account in the commerce system (select at checkout). If you do, a user profile is created and saved on the system. A saved user profile makes it easier and faster to check out the next time you make a purchase. The user profile saves your personal information. The password that you choose is encrypted in the system. The password is not visible to anyone but can be changed if needed.

All payments on the website are made by linking to PayPal. PayPal does the payment processing and then confirms the payment has been made and sends information back to our website via a transaction ID. Our website does not keep or even see any PayPal sign-on or credit card information.

Use of Information

We do NOT sell, rent, lease, or share your email address or other personal information with any groups outside of the Summit Club.
